

U.S. DOJ Overview

This mission of the U.S. DOJ enforce the law and defend the interests of the United States according to the law; to ensure public safety against threats foreign and domestic; to provide federal leadership in preventing and controlling crime; to seek just punishment for those guilty of unlawful behavior; and to ensure fair and impartial administration of justice for all Americans.

The DOJ FY 2017 Budget totals \$29.0 billion in discretionary budget authority. The FY 2017 DOJ Budget delineated by category is: law enforcement (49%); litigation (12%); prisons and detention (30%); administration/ technology/other (2%) and grants (7%). In addition, DOJ is estimating \$10.2 billion in mandatory budget authority in FY 2017.

U.S. DOJ Primary Youth Related Programming/Resources:

Within the U.S. Department of Justice (DOJ), primary focus on youth issues takes place within the Bureau of Justice Programs' Office of Juvenile Justice and Delinquency Prevention (OJJDP), although there are other places where youth programs and resources live within the DOJ. The following resource compilation includes programs and initiatives within the U.S. DOJ focused on health and safety of children and youth.

The type of resource included below is noted as:

A = agency, center or division within DHHS

Operated by the Institute for Intergovernmental Research on behalf of the OJJDP and the Bureau of Justice Assistance. NGC conducts research on street gangs, provides technical assistance and training to communities that are planning and implementing multi-strategy approaches to their gang problem, and training for state, federal, and tribal criminal justice personnel engaged in gang suppression. Website features: links to tools, databases, and other resources to assist in developing and implementing effective community-based gang prevention, intervention, and suppression strategies; findings from nearly 15 years of data from the annual National Youth Gang Survey; a database of gang-related state legislation and municipal codes; a list of newspaper articles on nationwide gang activity, updated daily; and GANGINFO, an electronic mailing list for professionals working with gangs.
