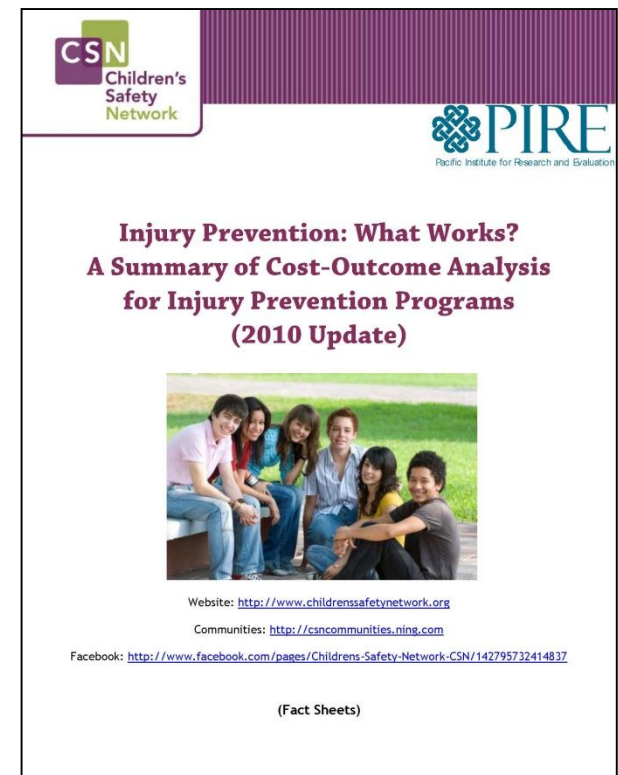
What We Do

- Support state planning and capacity-building for IVP.
- Promote use of evidence-informed interventions.
- Foster partnerships to ensure IVP activities are complementary, coordinated, and non-duplicative.
- Help states collect, analyze, and use data and provide them with incidence and cost data.
- Collaborate at the federal level to advance a national agenda for injury and violence prevention.



What Types of Services Does CSN Provide?

- Economics and Data Analysis & TA
 - Provides injury cost-modeling and data analysis
 - Produces state-specific data
 - Conducts trainings and webinars on injury data
 - Assists states in using their existing data

MCH Block Grant National Performance Measures

- **Existing**
 - Unintentional Motor Vehicle Traffic Deaths Among Children, Ages 0-14 Years
 - Suicide Deaths Among Youth, Ages 15-19
- **Possible New**
 - ✓ Percent of children and adolescents who are hospitalized and/admitted to an emergency room due to an injury
 - ✓ Percent of adolescents, ages 12-17 years, who are bullied

- Development of Resource Guide on Prescription Drug Abuse (in progress)



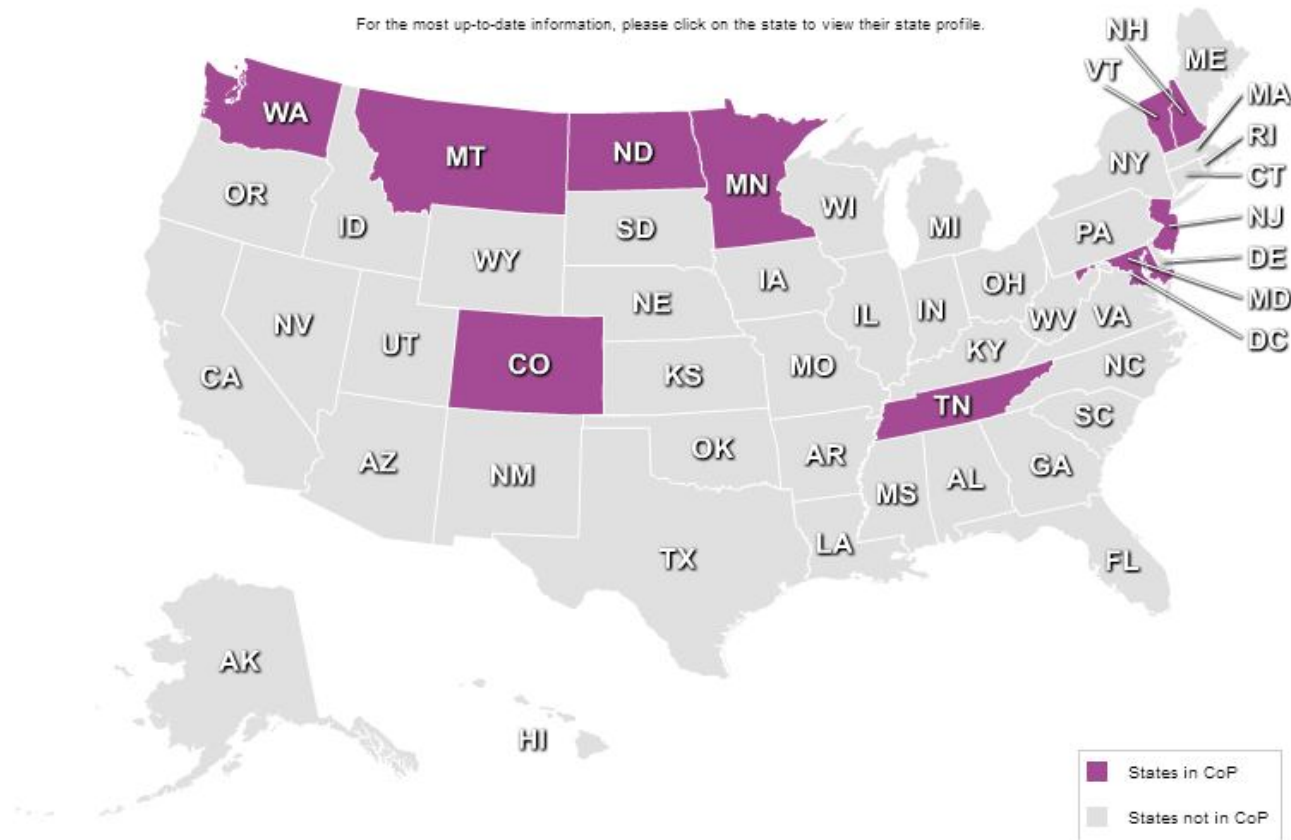
Distracted and Impaired Driving CoP

- Goal: Improve participants' knowledge of and ability to implement best practices related to innovative technologies, policies, laws, partnerships and programs that reduce the burden of distracted and impaired driving, especially as it related to teen drivers and their parents.
- Webinar Series of 12 from October, 2014 through September, 2015, plus ongoing technical assistance.
- As shown on the next slide, there are 15 state teams participating
- Each state needed to apply and identify a team lead and team members
- By the end of the CoP, each team will be expected to develop, begin to implement, and report on an action plan based on quality improvement principles, for improving the state's capacity to prevent DID driving.
